## **Dear Parents and Guardians**

In response to the Victorian State Government announcement last night that all Victorian State Schools will close tomorrow, Tuesday 24 March, I wish to clarify the following points which have caused some confusion for our community.

- State Schools will close to students only State School staff remain at work and are engaged in the planning for the potential of remote learning for their students
- State Schools have brought the upcoming school holiday period forward and those students are not receiving remote learning for the remainder of this week
- Oakleigh Grammar remains committed to our remote learning plan as communicated with you on Tuesday 17 March - our staff continue to work with students to deliver the best teaching and learning under these challenging circumstances
- Today teachers conducted lessons online from the School campus to our students at home
- Tomorrow teachers will test the on line lesson delivery from their own homes to our students at home
- On Wednesday classes will resume from the School campus to our students at home
- A review of what worked well and what we can improve will be conducted following both these trial to fine-tune and improve our remote learning offerings to students at home

It is critical for parents and care givers to work in partnership with the School in delivering our classes remotely. We seek parents support in ensuring students follow routine and remain engaged and focused during these unusual circumstances. Student rolls will be marked each day as attendance remains a requirement for the School and student reporting. Parents are asked to email absences in the usual way to absentline@oakleighgrammar.vic.edu.au

In addition, the State Ministers met on 20 March and have decided that NAPLAN will not proceed in 2020. This decision has been taken to assist school leaders, teachers and support staff to focus on the wellbeing of students and the continuity of online remote education. This cancellation applies to all Australian Schools including those in both Government and Independent sectors.

I wish to reassure families of our VCE students that our Head of Senior School, Sharron Frame is in regular contact with the Victorian Curriculum Assessment Authority (VCAA) regarding SACs, examinations and course delivery requirements. The VCE allows for considerable flexibility in delivery of learning and the administration of school-based assessments.
