### **Overview**

Oakleigh Grammar is a K to 12 co-educational Christian school. Over the years, Oakleigh Grammar has continued to reflect the changing face of its surrounding suburbs embracing and celebrating multiculturalism, diversity and inclusion.

Our Early Learning Centre (ELC) is inspired by the Reggio Emilia philosophy. Valuing each child as central to their own learning. Our staff believe that all children are a sacred gift from God and are full of curiosity and creativity.

- Providing high quality inclusive programs which are based on recorded observations and interpretation of children's responses, needs and interests.
- Showing care, respect and commitment to confidentiality in all interactions with children, staff and families.
- Providing information for families about the language program through discussions, and contributing to displays, reports and newsletters.
- Using principles of best practice to provide an innovative and responsive program.
- Upholding consumer rights, privacy, confidentiality and informed consent.
- Respecting the diverse needs of all community groups and individuals to ensure that their needs are met in an inclusive and sensitive manner.
- Other duties as directed.

## **Quality and Risk**

- Working cooperatively, ethically and respectfully with educators, parents, volunteers, students and other Oakleigh Grammar ELC staff to deliver high quality services for children and families.
- Supporting and maintaining the development of respectful and collaborative partnerships with children and their families, encouraging participation in the program where appropriate.
- Developing and forming contact with local community linkages and resources.
- Providing supervision and support to staff in accordance with Oakleigh Grammar ELC policies and procedures and in particular for the embedding of the language program into day to day practice.
